Forge Your Own Path in Healthcare



Gain the vital skills, critical thinking proficiencies and business acumen to guide the future of healthcare with a Master of Science in Healthcare Management from Michigan State University. The program's healthcarespecific courses address the study, application and research of healthcare management and compliance principles within a solid business framework, equipping graduates to champion collaboration, evidencebased decision making, and strategic and tactical thinking within their organizations.

MSU's M.S. in Healthcare Management program incorporates the professional knowledge of healthcare industry experts through the HCM Industry Advisory Board, with members serving as ambassadors for the program to the broader community and as advisors to the program's leaders, faculty and students.













Critical Thinking and Innovation in Healthcare

Learn strategies for dealing with cognitive biases, making unrecognized assumptions, determining causality, navigating pathways in critical reasoning and maximizing reasoning effectiveness. Apply innovation principles for developing and implementing innovative designs, processes and leadership in healthcare.

Law and Ethics in Healthcare

Understand the legal and ethical doctrines, principles, applications and issues in healthcare organizations. Explore the legal and ethical dimensions of decision making, administrative law and planning in healthcare.

Organizational Behavior in Healthcare

Discover the role of workforce leadership in fulfilling the goals and mission of healthcare organizations. Learn about the theories and applications of organizational behavior principles to motivating, rewarding, and structuring employees' work; managing groups and teams; and structuring the organization.

Analytics in Healthcare

Learn strategies to better assess cost effectiveness, learning curves in the practice of medicine, and identifying best practices for evidence-based medicine. Analytics in Healthcare will offer an overview of the concepts and methods of business analytics as it relates to healthcare management.

Cost Analysis in Healthcare

Topics include A) cost analysis: cost estimation, cost allocation and cost behavior; B) pricing: revenue management and strategic product-mix decisions; C) profitability: analytical techniques for determining profitability of departments, services and patients; D) control: budgeting, variance analysis, coordination of activities among departments; E) contracting with suppliers and insurance companies.

Financial Management in Healthcare

Learn financial management tools for investment and financing decision-making in healthcare firms. Explore risk, valuation and capital budgeting. Understand how to analyze the financial condition of the firm through the examination of financial statements.

Quality, Risk, and Performance Management

Explore how to manage healthcare performance by means of quality initiatives, process management and risk management. The course will focus on relevant methods, principles, processes, strategies and systems thinking.

Healthcare Information Systems

Review issues in the management and implementation of healthcare information systems and application of information technologies to support the effective and efficient delivery of healthcare work processes to stakeholders. Explore the relationship between quality management and information management. Learn about technology standards, security, emerging technologies and healthcare analytics.

Human Resource Management in Healthcare

Discover the role of human resource management for healthcare organizations. This course focuses on strategies for human resource recruitment, utilization, productivity, compensation and development.

Healthcare Systems and Economic Policy

Understand the organization of U.S. health system, policy process and services. Review the dynamics of economic theory, valuation, financing and delivery of healthcare.

Healthcare Strategic Management

This course examines ways top managers create and sustain competitive advantage in today's challenging healthcare marketplace from a total firm perspective.

Supply Chain Management in Healthcare

Review the concepts and tools of supply chain management related to healthcare settings. Topics include management of resources, sourcing, operations, inventory, logistics and capacity for effective services, quality and cost performance.

Healthcare Services Marketing

Explore the principles and processes of marketing and its role in effectively managing healthcare services for improvement and policy making.

Hospitality and the Patient Experience

Discover the patient experience in healthcare as it relates to hospitality marketing, service quality management, patient well-being and the role that leadership plays in the process.

Managerial Epidemiology and Population Health

Review the epidemiological concepts for decision-making in healthcare organizations. Assess managerial strategies for applying population health principles to disease assessment, community forecasting, cost effectiveness and utilization of services.

Healthcare Management Capstone

The capstone class integrates the coursework, skills and perspectives in the program in a project, paper or practicum. The capstone is intended to bring cumulative knowledge to culmination on specific healthcare management issues, dilemmas and gaps. Each capstone project, paper or practicum must be approved in writing and overseen by a faculty member.

Diversify Your Skills with a Graduate Certificate

MSU provides more ways to advance your healthcare education with two specialized graduate certificate programs: the **Graduate Certificate in Healthcare Compliance** and the **Graduate Certificate in Healthcare Leadership**. Both programs can be completed in ten credit hours, with four required courses and the choice of one (or more) elective.

Healthcare Compliance

Examines topics in healthcare regulations, enterprise risk management, healthcare compliance and compliance systems.

Healthcare Leadership

Focuses on strategic decision making, market analysis and planning, negations and leadership.

These options can be completed in addition to earning the Master of Science in Healthcare Management. They also allow the opportunity to gain targeted knowledge in a specific field of interest and pursue advancement without committing to a full graduate degree.



Savings and Assistance Available

Corporate Tuition Assistance

Corporate tuition assistance is paid by your employer. You will need to provide appropriate forms for processing, prior to enrollment. Air Force tuition assistance is available for active-duty service members. You will need to provide a valid military tuition assistance voucher. Both TA options are subject to employer benefit policies.

Federal Student Aid – You Could Qualify for Up to \$20,500 a Year Toward Your Degree

Federal student aid programs are the largest source of student aid in America. Take advantage of this opportunity by determining your eligibility with the Free Application for Federal Student Aid (FAFSA). For more information, visit MSUonline.com, email finaid@ msu.edu or call 517-353-5940.

Federal Direct (Stafford/Ford) Loans

Federal Direct Loans are available to graduate degree students and must be repaid - typically via installment payments upon graduation. Students are eligible to borrow up to \$20,500 per year.*

Alternative Loans

Many financial institutions offer student loans that can supplement your other sources of financial aid and make it easier to manage your education expenses. Check with your bank or credit union to see if it has a student loan program. You can also research lenders on the Internet. Students are advised to compare loan programs before choosing a lender. Interest rates, fees, and other provisions of these programs are subject to change by the lender. Contact lenders directly for detailed information on individual loan products.

Convenient Payment Options

All major credit cards are accepted for tuition payments and related expenses. To help minimize finance charges, Michigan State University offers several interest-free payment options that divide tuition and other fees into multiple payments over the course of each term.

Military Tuition Assistance

The U.S. Military's tuition assistance program pays up to 100% of tuition fees for full-time, active-duty servicemembers in any branch of the military, up to a maximum of \$250 per credit hour and a personal maximum of \$4,500 per fiscal year for each student.

Post-9/11 G.I. Bill[®], Montgomery G.I. Bill[®] and Educational Assistance Programs

Federal Direct Loans are available to graduate degree students and must be repaid - typically via installment payments upon graduation. Students are eligible to borrow up to \$20,500 per year.*

Exclusive Military Savings

Active-duty servicemembers, guardsmen, reservists, veterans, military spouses, and dependents of deceased or disabled veterans are eligible to receive 10% off the graduate course tuition.

Reductions are valid off the standard tuition and program fee rate of any degree or certificate offered through Bisk Education. This reduction is not stackable with other reductions, and you may not use this reduction in conjunction with other reductions.

College Fund Programs

The Department of Defense offers a College Fund program – also referred to as a G.I. Bill® Kicker – that can increase a servicemember's basic monthly education benefit. Each service branch determines eligibility and benefit amounts for its College Fund. This benefit is an addon to the G.I. Bill® and disbursed with an individual's monthly G.I. Bill® payments.

College Loan Repayment Program

The College Loan Repayment Program is an enlistment incentive offered by several branches of the U.S. Military and Reserves. It repays a portion of eligible student loans for non-prior service enlisted personnel. The program is currently offered by the Army, Navy and Air Force, as well as the Army and Navy Reserves.
